2. Sanction of the Governor of Haryana is hereby accorded to free travelling facilities to press Reporters/Correspondents in Haryana Roadways Volvo/AC Buses within the Jurisdiction of State including Delhi and Chandigarh as per following terms and conditions:-

- (i) "2 Nos. of seats may be kept reserved for press reporters/press correspondents in the Volvo/AC buses of Haryana Roadways from the starting point of bus. It shall be made clear that the press reporters/correspondents shall not claim seat in the mid journey, in case the seat is not available."
 - ii) The facilities shall be allowed to the accredited journalists and Desk journalists on the recommendations of DPR, Haryana, however, I-Card and log book for entering the kms of journey availed will continue to be issued by General Manager, Haryana Roadways Chandigarh.
 - (iii) The other terms and conditions issued vide Memo No. 19/3/2007-2T(II) dated 19-07-2007 remain the same.
